Redwood Heroes is an employee recognition program in The MENTOR Network's Redwood group that distinguishes exceptional contributions that directly impact the individuals we support. One Redwood Hero, per guarter, is further recognized as the Grand Hero. We are proud to announce that this guarter's Grand Hero award went to Tammy. Here is her story...

Tammy supports a non-verbal man who has a diagnosis of autism and has lived in a REM lowa home for the last seven years. This past

> fall, Tammy observed that the man was atypically tired, congested, and coughing. These symptoms were so unusual and troubling that he was taken to the emergency room The ER physician examined the individual, but felt a chest Redwood Heroes

x-ray was

probably unnecessary; however Tammy, knowing him so well, firmly urged that he have the x-ray anyway, before leaving the ER. The x-ray results revealed bilateral pneumonia and the individual was admitted to the ICU for treatment. The ER physician thanked Tammy for her advocacy and commitment to this man and stated it was possible he may not have made it through the night, had she not pushed for further evaluation of his symptoms. Due to Tammy's familiarity with the individual and courage to speak up on the man's behalf, he was accurately diagnosed and promptly treated.

Tammy is a fierce advocate for this individual and his roommates. She knows them so well that when something is not quite right, she senses it and is quick to seek assistance. n October of 2016, **REM Iowa's Intermediate Care Facility (ICF)** in Washington was recognized for a very special accomplishment: The facility earned a rare, deficiency-free survey from the **Iowa Department of Inspection and Appeals (DIA)**. This is the first deficiency-free survey the Washington facility has ever received. Annually, DIA surveys ICF facilities throughout the state, evaluating quality of care, dietary services, member involvement in the community and home, nursing care, and a whole host of other quality indicators - 389, to be exact. So, a deficiency-free outcome is a remarkable achievement that we felt deserved a celebration.

4dvocacy Corner

APRIL 1, 2017 marks the one year anniversary since the implementation of IA Health Link, Iowa's Medicaid managed care program. While we have experienced some bumps in the road, REM **Iowa** diligently continues to work with the three managed care organizations to resolve these challenges and issues. Up to this point in time, we have continued to provide the same supports and services as we did in years past. The media has publicized information related to the massive losses the three managed care organizations have reported. Per a spokeswoman from the **Department** of Human Services, some losses are expected, as the managed care organizations are making a longterm investment in Iowa's Medicaid program. This kind of information, however, can be unsettling and does not go far to ease the minds of providers, guardians, families, and members signed up for IA Health Link.

In February, we learned that AmeriHealth Caritas of Iowa, the managed care organization with the largest number of Long Term Services and Supports (LTSS), ANNIE sent letters to providers who negotiated STRENG rates above the floor rate (set by the state of lowa) stating that, after April 1, Dievelopment Director 2017, they would no longer pay above the floor rate. On February 10, they also announced that they would be ending some of their contracts with communitybased case managers and gradually moving these services in-house - also starting April 1 – in an effort to "improve consistency in the case management processes and recommended services". For some, this news brings questions and concerns. What is important to remember is that we at REM lowa continue our dedication and commitment to those receiving our services and

blessed to support as well as other stakeholders.

REM lowa continues its efforts to advocate for the members we serve and for all Iowan's under the managed care umbrella. There are system issues at the state and legislative level that must also be addressed, in addition to accountability from the managed care organizations. On March 7 2017, Lisa Pakkebier, Executive Director and I had the pleasure of meeting with Senator Liz Mathis, Ranking Member of the Senate Committee on Human Resources, and Senate Democratic Leader **Robert Hogg** at the Capitol to address some of these issues. While we know change is not immediate, we feel it is vital for all stakeholders' voices to be heard with legislators at a local and federal level. Many providers, family members, guardians, advocacy

groups, and other stakeholders are sharing their stories and advocating on behalf of this vulnerable population. We will

continue to advocate and encourage others to start and/ or continue their efforts. There are

them. From supporting children in their academic pursuits to providing clothing and school supplies to foster families throughout the year, FHF helps better the lives of thousands of Iowa's children. Their Spread Your Wings Program provides scholarship funding for children in family foster care to gain self-confidence by supporting their participation in extracurricular activities, such as sports, art, music lessons, dance, gymnastics classes, martial arts,

Special Olympics, and summer camps. Because the stipend foster families receive often only covers the basic expenses of welcoming a child into their home, the "extras" often have to be bypassed. The Community PAKKEBIER Partner grant from The MENTOR Network Charitable Foundation will support

additional scholarships for these youth.

REM Iowa started a wellness program on February 1, 2017. The REM Iowa MOVEment is a voluntary program for all individuals receiving services and for all staff. The intent is to Move Ourselves Voluntarily Everyday (MOVE), with an emphasis on making better dietary choices, overall wellness, and maintaining an active lifestyle. Points were earned for exercising, monitoring food portions, drinking water, not eating fast food, not having pop/soda, and not using tobacco products. There have been many positive changes noted and much excitement for the "MOVEment". The first 'season' of the REM Iowa MOVEment ended March 17, 2017. It was quite a battle amongst all the teams, with "I Like to Move It, MOVE it" narrowly claiming victory over "Gym-n-Tonic" by nine points.

"Season 2" of REM Iowa's MOVEment began March 19, 2017 and is a "Biggest Loser"-like competition. Using learned tools/skills from the first challenge, this next phase is a self-motivated, volunteer challenge, open to all those individuals receiving services and all staff. Additionally, the office that loses the most pounds will win the team challenge.
